2024 Diocesan Ministry Appeal Grant Guidelines

Appeal Grants Mission

The Diocesan Ministry Appeal Grants for Parish Support is an act by the Bishop, in his duties as Shepherd of the Diocese, to promote and to safeguard the unity of faith and the discipline common to the whole Church, to instruct the faithful to love the whole Mystical Body of Christ and to promote activity of the Church, especially that the faith may increase and the light of full truth appear to all. The Appeal works with parishes to fund educational, pastoral, and charitable programs, in so far as it is able, by careful discernment of these apostolates and initiatives.

Purpose

Grow and strengthen ministries and programs in diocesan parishes through the support of:

- Outreach Programs (i.e., Evangelization Ministry, catechesis events, discipleship, youth programs, etc.)
- Retreats
- Materials and other resources needed to support parish ministries
 - May include building or infrastructure maintenance if directly tied to a parish ministry.

Ineligible for Funding

The following are ineligible for funding from the parish support grant:

- Debt payments
- School operating expenses (there is a separate application for School Support grants)
- School tuition assistance (this is funded in a different distribution)

Eligibility

All parishes may apply for funding once per year. Grants will be considered based on conditions to include:

- Parish met their Annual Appeal goal the previous year; is on track to meet goal for current fiscal year
- Parish is current on any outstanding loans/payments to the diocese
- Parish is current in their accounts payable to the Diocese

Application Requirements:

- Parish provides a proposed budget for the upcoming fiscal year
- Parish provides budgets or cost estimates for the purposes outlined in their grant application
- Parish provides a grant application that is complete in its entirety, including all signatures

Grant Sizes/Structures

Grants are structured based on the amount of funding the Annual Appeal receives in a given year. The Advisory Committee will determine which parishes will receive a grant based on their application and amount of funding available from appeal collections. Some grants may be awarded in whole, or in part, of the requested amount.

Appeal Advisory Committee

The Appeal Advisory Committee consists of priests and lay parish representatives from all Deaneries in the Diocese. Committee members are asked to serve a two-year term. The current Committee's term expires at the end of 2025. Members are eligible to serve an additional term.

To Apply for a Grant

Parishes may submit applications via email and are asked to please combine the entire application in a single PDF attachment.

Deadlines

Applications are accepted year-round but must be received no later than May 31, 2024, to be considered.

Debt payments and school support expenses **are not eligible** for a parish support grant. There is a separate application for School Support Grants.

Examples of eligible parish expenses include new program salaries, retreats, outreach programs, materials and other resources needed to support parish ministries, and infrastructure maintenance or building projects that are directly tied to a parish ministry and fall within the ordinary administration of a parish. *Please **do not** ask for or anticipate multi-year funding. We require a new application and updated budget information each year.*

With these guidelines in mind, please briefly identify the purposes for a **Parish Support Grant** in the space below:

The following information and items must accompany the application form:

1. Grant Narrative Statement (see reverse side)
2. Supporting documentation, such as cost estimates, examples, supportive documentation or photographs.
3. Upcoming fiscal year Parish budget information. **When submitting the Parish Budget information, do not include revenue from this grant in your anticipated revenue.**

This application must be signed by the Pastor or Parochial Administrator and the Chairs of the Pastoral and Finance Councils. ***If a grant is awarded, funds will be distributed only for the need described in this application and approved by the Bishop.***

FY2024 **IMPORTANT DATES**

March 15, 2024	Office of Stewardship and Development (S&D) emails the Appeal Grant Application to all parishes.
May 31, 2024	Deadline for parishes/schools to return completed Grant Application and all materials to Jennifer Bernal at jbernal@diocs.org. Parishes/Schools will not be able to move on to the next step of the process unless they submit all materials in a timely fashion.
June 3-17, 2024	Finance Office and Stewardship and Development review of Grant Application.
June 18-28, 2024	Appeal Advisory Committee Grant Applications Review Parishes, schools, and affiliated organizations may be contacted by Office of Stewardship and Development if committee needs clarifications on any part of the grant.
July 1-15, 2024	Final recommendations of Advisory Committee submitted to Bishop Golka.
July 15-31, 2024	Notification calls/emails to all grant requesters. S&D Office is also available to schedule meetings to discuss or clarify decisions.
August 1-31, 2024	Identified grant recipients receive awarded funds.
May 31, 2025	Follow-up Impact Report due from all recipients of grant funds.
